August - May

# GHS PTA - April Elections

#### summarized from GHS PTA Bylaws

#### Section 2. Officers and election:

- a. The officers of this association shall be president, vice president, secretary, and treasurer.
- \*b. Officers shall be elected in the month of April.
- \*c. The vote shall be conducted by ballot and a majority vote shall elect. When there is but one candidate for any office that election may be held by voice vote.
- \*d. Officers shall assume their official duty July 1 and shall serve for a term of two (2) year(s) or until their successors are elected and assume office.
- \*e. No officer shall serve more than two (2) consecutive terms in the same office.
- \*f. A person who has served in an office for more than one half of a full term shall be deemed to have served a full term in such office.

#### Section 4. Nominating Committee:

- \*a. There shall be a nominating committee composed of three (3) members who shall be elected by the board of directors of this local PTSA at two (2) months prior to the election of officers.
- \*b. The nominating committee shall;
- i. Elect a chair;
- ii. Nominate at least one (1) eligible person for each office to be filled and report its nominees at the regular membership meeting at least thirty (30) days prior to the election.
- c. Additional nominations may be made from the floor at the election meeting.
- \*d. Only those individuals who are current members of any local PTA/PTSA and who have signified their consent to serve if elected shall be nominated for, or elected to, such office and must become a member of this PTSA at the beginning of their term of office.
